

Customs and Excise (Suspension) (Amendment) Regulations, 2019
(No. 221)

IT is hereby notified that the Minister of Finance and Economic Development has, in terms of section 235 of the Customs and Excise Act [*Chapter 23:02*], made the following regulations:—

1. These regulations may be cited as the Customs and Excise (Suspension) (Amendment) Regulations, 2019 (No. 221).

2. The Customs and Excise (Suspension) Regulations, 2003, published in Statutory Instrument 257 of 2003 (hereinafter called “the principal regulations”), are amended by the insertion of the following section after section 9K—

“Suspension of duty on power equipment, critical spares and transformer components imported by ZESA Enterprises (ZENT), Zimbabwe Electricity Transmission and Distribution Company (ZETDC), the successor company of Zimbabwe Electricity Transmission and Distribution Company (ZETDC) and Zimbabwe Power Company (ZPC)

9L. Subject to this section and to such conditions as the Commissioner-General may fix, a suspension of duty shall, for a period of two years with effect from 1st June, 2019, be granted on power equipment, critical spares and transformer components imported by ZESA Enterprises (ZENT), Zimbabwe Electricity Transmission and Distribution Company (ZETDC), the successor company of the Zimbabwe Electricity Transmission and Distribution Company (ZETDC) and Zimbabwe Power Company (ZPC), with the following tariff headings and codes—
